Update August 2024

Outcome of the Proposed Revised Method for Calculating Local Housing Need in England


The Government is proposing a revised standard method for calculating local housing need in England to align more closely with its aspirations to boost housebuilding and grow the economy.

The proposed revised method results in a national need for 371,541 new homes to be built per year, in-line with the Government's commitment to deliver 1.5 million new homes by 2029.

The housing need figures resulting from the revised method are proposed to become mandatory housing targets for each local authority. The current and proposed figures for each local authority are presented in regional tables in the subsequent pages of this document.

Key observations include:

- The revised method results in a +22% national increase in new homes per year above the need from the current standard method (305,223 homes per year)
- Housing need increases in all English regions, except London where it reduces



- Housing need reduces in 49 authorities:
 - 11 are authorities which previously received the cities uplift
 - 24 are London Boroughs

Comparison of the current and revised method

The proposed changes are outlined in the National Planning Policy Framework (NPPF) consultation which was released on 30 July 2024. The table below represents a summary of the proposed changes.

† Under the current standard method, the 35% cities and urban uplift is applied to London (not individual London Boroughs) and it is the responsibility of the Mayor to determine the distribution of housing need across London through the SDS (London Plan). Therefore, the standard method need for London exceeds the sum of those calculated for individual authorities. To ease comparison, the indicative numbers as provided by MHCLG in 'Outcome of the proposed revised method' are shown in the current method column. The sum of these is very close to the London total provided, which includes the uplift.
